NOTEWORTHY LANDSCAPE FEATURES: Walk through flower garden.

ASSOCIATED STRUCTURES: Shed.

KNOWN ARCHAEOLOGICAL FEATURES: None.

GEOGRAPHIC SETTING: Well-sited below grade of Fourth Avenue on the lower side of Fourth. Occupies interior lot abutting unimproved alley. House is between unbuilt Apperson Street and Blanchard Street pedestrian stairs.

STATEMENT OF SIGNIFICANCE: (Historical and/or architectural importance, dates, events, persons, contexts): George and Martha Draper parented a large family, a number of whom made their livings in Canemah in the 1880's. Draper himself was born in New York in 1823, and served as a school teacher in Canemah. This house was one of a number of properties owned by the Drapers. The house was also owned in the 1890's by Daniel and Lena Klemsen. The house is significant for its architectural detailing, including the original pedimented windows on the north side, for its association with Draper, and for its style. It is one of several Gothic Revival structures in Canemah and one of just a few in Oregon City.



