



## Addendum D – Elective Street Tree Removal

### Street Tree Removal and Replacement Application

Street trees that are 1) in planter strips wider than 3 feet, 2) not nuisance species, 3) not dead, diseased, or hazardous according to a Certified Arborist Report, or 4) not lifting the sidewalk more than 1/4 inch may be removed, provided they are replaced according to the size of the tree(s) removed.

Number of trees up to 6" diameter at 4 feet above ground (DBH) to be removed \_\_\_\_\_ x 1 =

- *One replacement tree is required for each of these trees that are removed.*

Number of trees 6" to 12" DBH to be removed \_\_\_\_\_ x 2 =

- *Two replacement trees are required for each of these trees that are removed.*

Number of trees 13" to 18" DBH to be removed \_\_\_\_\_ x 3 =

- *Three replacement trees are required for each of these trees that are removed.*

Number of trees 19" to 24" DBH to be removed \_\_\_\_\_ x 4 =

- *Four replacement trees are required for each of these trees that are removed.*

Number of trees 25" to 30" DBH to be removed \_\_\_\_\_ x 5 =

- *Five replacement trees are required for each of these trees that are removed.*

Number of trees 31" DBH or larger to be removed \_\_\_\_\_ x 8 =

- *Eight replacement trees are required for each of these trees that are removed.*

**What is your replanting plan? All replacement trees:**

1. Must be at least 1.5 inches in caliper measured 6 inches from the ground at the time of planting.
2. Must meet the spacing requirements shown on the application page.
3. Must be chosen from the **Adopted Street Tree Species List** based on the width of the planter strip.
4. Can be alternatively chosen
  - a. from another Metro Area city's Street Tree Species List if you supply a copy of the list, or
  - b. by written recommendation of a Certified Arborist.
