\*Within the Mixed Use Downtown District, Willamette Falls Downtown Design District and Mixed Use Corridor 1 District the number of signs placed within the right-of-way is limited to the number of public entrances per building, up to three (3). In other Commercial and Industrial zones, each property is allowed one (1) A-frame sign in the right-of-way per frontage. In Residential areas, one (1) A-frame is allowed per frontage, during specified hours.



## SIGN PERMIT

Depending on the display time, the sign may require a permit from the Planning Division. Upon approval of the sign permit, the City will provide you a sticker to place on the sign to show it is approved.



## Placing an A-Frame Sign on the Sidewalk in Oregon City\*

\*Only applies when placing a sign within the right-of-way in non-residential zoning designations.





## DESIGN

The sign must:


- Be an A-frame sandwich design
- Have a frame which made of wood, plastic or metal
- Be portable
- Not be illuminated
- Comply with the dimensions above
- Be no larger than 6 feet square per side

## RULES FOR PLACING A-FRAME SIGNS

Signs may not be placed in parking spaces, pedestrian pathways, bicycle paths, street corners, transit stop areas, ADA accessways and ramps, at building exits or fire escapes, in any portion of the street, or impede the vision of drivers or bicyclists.

## ALLOWED HOURS OF PLACEMENT

- With a Permit:  
Everyday: 9 a.m. - 10 p.m.
- Without a Permit:  
Thursday-Sunday: Noon - 8 p.m.  
Tuesday: 6 a.m. - 1 p.m.



## NUMBER OF SIGNS

One (1) A-frame sign may be allowed within the right-of-way per frontage.

Within the Mixed Use Downtown District, Willamette Falls Downtown Design District or Mixed Use Corridor 1 District the number of signs placed within the right-of-way is limited to the number of public entrances per building, up to three (3).
