



### Addendum 11: Temporary Structure

#### Type I Minor Site Plan & Design Review

Temporary structures must demonstrate compliance with building materials, dimensional standards including setbacks, and temporary structure code. Temporary structures are exempt from all sections of the OCMC 12.08, 16.12, 17.52 and 17.62 EXCEPT **17.62.050.I and 17.62.050.J.**
