ARCHITECTURAL / PROPERTY DESCRIPTION

(Include expanded description of the building/property, setting, significant landscape features, outbuildings, and alterations)

The house is located on a level bench on the south side of 3rd Avenue at unimproved Hedges Street as the avenue ascends the hillside. The two level home has a side gabled roof with a full width front porch with hipped roof supported on four posts that faces the street.

Exterior Materials: composition shingles at roof, center brick chimney; channel siding, corner boards, plain and minimal trim; board formed concrete foundation. Front porch has chamfered posts and railing with square pickets, concrete foundation under porch. Windows: wood double hung at porch next to half light panel entry door; wide fixed sash window may have replaced earlier double hung window(s); Other windows replaced with aluminum sliders; all have plain trims.

Alterations: There have been minimal alterations including the window replacements, and rear porch enclosure with ramp access to upper level. The 1911 Sanborn map indicates a rear porch on the west end and a one story addition on the east end with an accessory structure further south.

Landscape: House is located close to both street lines and immediate yard has minimal planting; the portion of the lot uphill to the south is wooded with native vegetation. There is an unmortared stone wall behind the house and another one that is ivy covered slightly above.

HISTORY

(Chronological, descriptive history of the property from its construction through at least the historic period [preferably to the present])

Louis Paquet, born in Missouri in 1845, was a ship carpenter as were his brothers, Peter and Joseph, and his father Francis Xavier. Francis X. (1811-1896) had been a fur trapper with the American Fur Company in his younger years. He lived in Chicago and Wisconsin before coming west on the Oregon Trail in 1852. He and his wife Marie Louise (b.1818) lived in Canemah for a year, then purchased Donation Land Claim in the vicinity of New Era, to which they moved. They returned to Canemah in 1863 and most of the family remained until the late 1880's-early 1890's when they moved to Portland.

Francis X. and his three of his sons, Louis, Peter and Joseph were highly skilled carpenters, bridge and boat builders. The Paquets had twelve children and in addition to this house owned what was formerly known as the "Coburn house" (b.1864) at 902 So. McLoughlin. The ownership of this 3rd Ave. house is not clear, but perhaps it was occupied by Peter and his wife Sarah, who were married in 1871. The 1870 census indicates Francis X. and Marie Louise Paquet and eight children living in one household in Canemah.

In 1883 Peter built a covered bridge, Baker's Bridge over the Clackamas River, at Stone (now Carver). By the late 1880's the Paquets had moved to Portland where Louis, Joseph and Francis A. continued in ship repair and boat building well into WWI. Peter also engaged in banking, and the development of gas lighting in that city.
