

Council Chamber, Oregon City, Oregon,

November 5th, 1913.

The City Council of Oregon City met in regular session on the above date at 8 o'clock, p.m.

The minutes of the meetings of the City Council held on October 29th and 31st were read and approved.

The communication of the Portland Railway, Light and Power Company in regard to the arc light to be placed at the corner of Fourth and Monroe Street was read and ordered filed.

The petition for a light at Molalla Avenue and Warren Streets was referred to the Committee on Streets and Public Property and the City Recorder to write to the Portland Railway, Light and Power Company for estimates of the cost of installing same.

The report of the City Recorder for the month of October, 1913, was read and ordered filed.

The report of the Chief of Police for the month of October, 1913, was read and ordered filed.

The City Engineer filed his certificate of the acceptance and approval of the work done on Sixteenth Street and the City Council has set the 26th day of November, 1913, at 7:30 o'clock, p.m. in the Council Chamber as the time and place of hearing of objections to such acceptance.

The reading of the new garbage ordinance was postponed until the next meeting of the City Council.

The following Ordinance entitled "Ordinance No. ____ An Ordinance fixing the tax levy for general municipal purposes and for the Permanent Street Improvement Fund for the year, 1913, and making a tax levy for said year for said Purpose" was read first time and ordered published and to

come up for second reading and final passage at a special meeting of the said city council to be held on the 26th day of November, 1913, at 7:30 o'clock, p.m.

The following Ordinance entitled "Ordinance No. ___ An Ordinance fixing the tax levy for the Oregon City Library Fund, for the purpose of assisting in the maintaining of same, for the year, 1913, and making a tax levy for said year for said purpose" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said City Council to be held on the 26th day of November, 1913, at 7:30 o'clock, p.m.

The following Ordinance entitled "Ordinance No. ___ An Ordinance reducing the size of the alley running through Block 109, Oregon City Oregon, from 26 feet in width to 16 feet wide and vacating a strip of land on each side of said alley and five feet wide and attaching each of said alley and five feet wide and attaching each of said strips to the lots bordering on said alley" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the said city council to be held on the 26th day of November, 1913, at 7:30 o'clock, p.m.

The following Ordinance entitled "Ordinance No. ___ An Ordinance changing the grade of John Adams Street, Oregon City, Oregon, from the South side of Third Street to the South side of Twelfth Street" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the City Council to be held on the 26th day of November, 1913, at 7:30 o'clock, p.m.

The following Ordinance entitled "Ordinance No. ___ An Ordinance changing the grade of Harrison Street, Oregon City, Oregon, from the North side of Seventh Street to the South side of Eighth Street" was read first time and ordered published and to come up for second reading and final passage at a special meeting of the City Council to be held on the 26th day of November, 1913, at 7:30 o'clock, p.m.

The following Ordinance entitled "Ordinance No. ___ An Ordinance adopting the report of the Viewers of Benefits and Damages for the establishing of a Street on the Bluff between Sixth and Seventh Streets Oregon City, Clackamas County, Oregon, and appropriating the necessary land therefore,

Whereas, the committee appointed to assess the damages and benefit for the condemnation and appropriation of land to establish a street between Sixth and Seventh Streets and described, as follows:

Beginning at a point two (2) feet southerly from the northeast corner of Lot 1, Block 34, Oregon City, and on the property line of High Street, thence five (5) feet on a line 45° to the right from

High Street to the B.C. of a curve having a radius of 331.1 feet, thence on said curve 245.2 feet, more or less to the E.C. (said curve to have a central angle of 42° 36') thence on a tangent to said curve at said E.C. 49 feet more or less to the North line of Sixth Street at a point 103 feet from the West line of High Street, have made their report and said report appears to the Council to be just and it appearing to the Council after due and full consideration thereof that the said report is in all respects reasonable and just," was read second time and placed upon its final passage and it appearing from the certificate of Charlotte Baker, principal clerk of the publisher and printer of the Morning Enterprise that the same had been properly published as required by the charter and on motion and roll call the Ordinance passed, the vote being as follows:

The matter of the Tooze assessment on Thirteenth Street was referred to the following councilmen: Beard, Hall and Meyer.

The bid of Morris Brothers for the Elevator Bonds was referred to the Finance Committee.

The following were appointed as judges and clerks of election for Ward No. 1. H.W. Trembath, John Bradley, W.W. Myers, Eugene Woodward and Arthur Rugg.

Ward No. 2. Sol Walker, A.F. Jack, Roy Cox, Fred Greenman and George Hoeye.

Ward No. 3. Ed Scott, John Gillette, Fred Curren, F.M. Darling and Erastus Smith.

On motion the Mayor was request to appoint a time for the Clackamas Southern Franchise and the Carver Franchise on Water Street. Wednesday the 12th day of November, 1913, at 7:30 o'clock, p.m. was the date set.

The bond of the Oregon Engineering and Construction Company for the improvement of Seventh Street was referred to the Finance Committee and the City Attorney.
